WHEREAS, the Town Board of the Town of Dresden, Washington County, New York, has had under consideration the increase and improvement of the facilities of the Hulett's Landing Sewer District #1 in said Town (the "District"), consisting of reconstruction and relocation of a force sewer mains currently over Foster Brook including original furnishings, equipment, machinery, apparatus, appurtenances and incidental improvements and expenses in connection therewith; and

WHEREAS, it is determined that the maximum estimated cost to said Districts of such joint increase and improvement of facilities is \$200,000.00; and

WHEREAS, such cost shall be annually apportioned among the parcels in said District by said Town Board, and the amounts so apportioned shall be levied and collected in said District in the manner provided by law; and

WHEREAS, it is anticipated at this time that the apportionment of cost in said District shall not exceed \$200,000.00; and

WHEREAS, said capital project has been determined to be an Unlisted Action pursuant to the regulations of the New York State Department of Environmental Conservation promulgated pursuant to the State Environmental Quality Review Act ("SEQRA"), and it expected to be determined to not result in a significant environmental effect and copies of SEQRA compliance documentation are on file in Office of the Town Clerk where it may be inspected during regular office hours upon appointment; and

WHEREAS, it is now desired to call a respective public hearing on the question of the joint increase and improvement of the facilities of all of said District in said Town in the matter described above, and to hear all persons interested in the subject thereof, concerning the same, in accordance with the provisions of Section 202-b of the Town Law;

NOW, THEREFORE, IT IS HEREBY

ORDERED, by the Town Board of the Town of Dresden, Washington County, New York, as follows:

Section 1. A public hearing will be held at the Town Hall, 102 Clemons Road, Dresden, New York, in said Town, on March 25, 2024, at 7:00 o'clock P.M., Prevailing Time, on the question of the increase and improvement of the facilities of said District in the Town of Dresden, Washington County, New York, in the manner described in the preambles hereof, and to hear all persons interested in the subject thereof, concerning the same, and to take such action thereon as is required or authorized by law.

Section 2. The Town Clerk is hereby authorized and directed to cause a copy of the Notice of Public Hearing hereinafter provided to be published once in the official newspapers of the Town and also to cause a copy thereof to be posted on the sign board of the Town, such publication and posting to be made not less than ten, nor more than twenty, days before the date designated for the hearing.

Section 3. The notice of public hearing shall be in substantially the form attached hereto as Exhibit A and hereby made a part hereof.

Section 4. This Order shall take effect immediately.
