ANY PERMIT APPLICATION RELATED TO PROPERTY WHERE A SEWER MAIN OR LATERAL IS LOCATED PURSUANT TO MAP FILED IN THE WASHINGTON COUNTY CLERK'S OFFICE AS MAP 21-78, FILED NOVEMBER 24, 1992 MAY, IN THE DISCRETION OF THE SUPERINTENDENT, REQUIRE A SURVEY BY A LICENSED LAND SURVEYOR SHOWING THE LOCATION OF ALL SEWER LINES SHOWN ON SAID MAP.

NOTE: By naming such designated agent, the applicant and the project's contractor agree to be bound by all decisions communicated by said designated agent to the Superintendent regarding the proposed project. By signing below, the designated agent assumes the responsibility of complying with the Town of Dresden sewer use laws and rules and acknowledges that he/she/it could be subject to enforcement action thereunder if necessary. Any permit issued by the Superintendent to construct sanitary sewer facilities or connections shall expire one (1) year from the date of its execution by the Superintendent.

The property owner will own and maintain the lateral up to the point of connection with Town of Dresden applicable sewer district sewer main, usually identified by the clean-out, but otherwise as determined by the Superintendent.

This permit does not convey legal access to any real property. This permit does not constitute a building permit which must be issued by Washington County Code Enforcement. This permit does not constitute compliance with any other laws or regulations including but not limited to those of the NYS Lake George Park Commission, New York State Adirondack Park Agency, New York State Department of Environmental Conservation, or United States Army Corps of Engineers, as applicable.
