

February 9, 2015 the regular Town Board meeting was held in Dresden Town Hall beginning at 7 p.m. with Coun. Greenough absent. The pledge to the flag was led by Sup. Gang. A motion to accept the previous month's minutes was made by Coun. Raymond and seconded by Coun. Barber and all were in favor. A motion to pay the audited bills was made by Coun. Wilbur and seconded by Coun. Barber and all were in favor.

Old Business: Sup. Gang looked into turning the Supervisor's Term into a four year term instead of the current two year term and the result is that the term can be changed by voting on it within 150 days of a general election and would take effect the following election.

Coun. Raymond wondered if there was a way to get voters registered on a town wide drive and Sup. Gang will look into it with the Board of Elections.

The Town is allowed to advertise local businesses on the town web site but it must be open to all businesses not just a few. Sup. Gang will talk to the town attorney and find out any additional details.

The town financials were given to the board members as well as the Town Clerk and 2015 is up to date and on file in the Clerk's office.

New Business: A letter was sent to Sup. Gang in regards to a private road located in Hulett's Landing to be taken over as a town road in order to be maintained during the winter months. Mr. Hobus has a copy of the town road policies and will look into what it would take to make a road up to state specifications. It is recommended that a policy should be implemented.

A copy of foreclosures located in the town was given to the board members. The property owners have up until the day of the sale to repurchase the parcel. A property owned by Will Rozell is on the list and is located directly next to the Town Pit and discussion ensued about a way that could be utilized by the town.

Resolution #5-2015 titled **Budget Amendment-General** was put forth by Coun. Raymond and was seconded by Coun. Wilbur and all were in favor and it's on file in the clerk's office.

Resolution #6-2015 titled **Budget Amendment-General** was put forth by Coun. Wilbur and was seconded by Coun. Barber and all were in favor and it's on file in the clerk's office.

Resolution #7-2015 titled **Standard Work Day Resolution** was put forth by Coun. Raymond and was seconded by Coun. Wilbur and all were in favor and it's on file in the clerk's office.

A question was brought to the board's attention in regards to a drug policy for all town employees. There is a paragraph located in the Trustee's Contract that addresses the issue and the only thing it states is as long as an employee retains a CDL license they will be subject to random drug testing but it is not necessary for general employment. It was recommended by the town attorney that a random drug test cannot be required due to infringement of the 4th Amendment however an employee can voluntarily offer to have one done. This issue may need to be addressed and updated at a later time for clarity.

County Business: During the Board of Supervisor's meetings discussions have included allowing the probation department case workers being able to carry a weapon during home visits for volatile situations. There was notification that this order was passed and that there shall be proper training provided to the officers. Also, discussions about the Medicinal Marijuana Initiative have been on the table. There are five approved growers in the state and three dispensaries located in each area. The use of marijuana for medical reasons has already been approved in the state and Sup. Gang was wondering how the board felt about a growing area located in Washington County being approved and how they would want Mr. Gang to vote during the next couple weeks.

Mr. Hobus was not able to attend the meeting due to a snow event therefore there was no Highway Superintendent's Report. There was no further discussions and the meeting adjourned at 7:59 p.m.
